

How to Format and Submit Your Manuscript for SCIS2014

Abstract— In this guide, we explain the method of preparing and submitting the manuscript for SCIS2014 (abstract and full paper). Abstract proceeding (printed) and full paper proceeding (CD-ROM) are scheduled to be distributed in SCIS2014. Authors are required to prepare both “Abstract within 650 characters” and “Full paper within eight pages”. The abstract is registered by text input, while the full paper is submitted by uploading an electronic file. **It is not necessary to submit the hard copy.** The registered “Abstract” and the submitted “Full paper” are collected for the printed abstract proceeding and the CD-ROM proceeding, respectively. In order to prevent troubles in the proceedings, please prepare and submit your manuscript according to this guide.

Keywords: SCIS 2014, manuscript style, file format.

1 Manuscript Abstract (Printed Abstract Proceeding)

A printed abstract proceeding will be prepared in SCIS2014. Please input the text of abstract on Web. It must be **within 650 characters**.

After participation application on Web, you can access “my page”. After registering for new presentation, you can input the abstract text under “Manuscript (abstract for printing abstract proceeding)”

2 Manuscript Main Text (CD-ROM Proceeding)

CD-ROM proceeding will be distributed in SCIS2014. Please prepare your full paper **not exceeding 8 pages**.

Since the submitted manuscript will be published as it is, please prepare the manuscript according to the following. Not that this document itself follows the recommended style for the proceeding.

2.1 Limitations of Document Size and Page Count

The paper size is set to be A4. The manuscript (main text for CD-ROM proceeding) must not be more than eight pages.

Please include the title, authors, affiliation, address, abstract, keywords, main text, diagrams, references, and appendices, etc. in the eight pages.

2.2 Layout of Manuscript

Please arrange the margins as follows: top margin 17 mm, bottom margin 20 mm, and the right and left margins 18 mm, respectively. Except these margins, please put the context in an area of height 260 mm and width 174 mm.

Moreover, please put the label of SCIS of height 16 mm and width 57 mm in the upper right corner of the first page. For the content and the style, please follow the label of SCIS in this document. It is not necessary to put the label after the first page. Paper number is also unnecessary.

Please **put page numbers in** the paper.

2.3 Composition of the 1st Page

The necessary items and languages for the first page of the text are summarized in Table 1.

Table 1: Necessary items and languages on the 1st page

Paper Language	Japanese	English
Title	J and E	E
Authors	J and E	E
Affiliation	J and E	E
Address	J and E	E
Abstract	J or E	E
Keywords	J or E	E

J: Japanese; E: English

J and E: Japanese and English is required

J or E: either Japanese or English

E: only English is required

The “Abstract” of the paper to be published in the CD-ROM proceeding need not be the same as the abstract shown in the abstract proceeding (but they can be the same).

2.4 Style File for L^AT_EX

For those who use L^AT_EX to prepare the manuscript, the L^AT_EX style file and the template file were prepared. Please acquire them from

There are both English version and Japanese version.

3 About Submitting the Manuscript

3.1 Presentation Application

For the presentation application, please register via the web page, under “Registration” in <http://www.iwsec.org/scis/2014/registration.html>. Then proceed to the registration of new presentation after login into “my page”.

3.2 Manuscript Registration and Submission

Please submit the abstract and the paper online. **It is not necessary to submit the hard copy.**

Please login to “my page”, in order to register and submit the manuscript through the submission page.

Deadline for submission is December 16, 2012 (JST). After the manuscript is submitted, it can be updated for any number of times until the deadline. The printed abstract proceeding and CD-ROM proceeding are based on the last version of any information submitted. Early submission is recommended because congestion in the server is expected in the last minutes of the deadline.

3.3 File Format

The abstract text is inputted on Web and the manuscript of the full paper must be in **PDF form**. Moreover, the file size of the full paper must not exceed 1.5MB for the convenience of making the CD-ROM. If your file is more than 1.5MB, it may not be put in the CD-ROM. Please take extra care if the file contains many photographs.

Please also note the following section “Fonts That Can Be Used”.

3.4 About Fonts That Can Be Used

The PDF file of the submitted manuscripts are collected to the CD-ROM proceeding “as it is”. Therefore, in order for it to be displayed correctly in different platforms, the following guideline is recommended.

Latin font It is safer to embed all the fonts used.

Japanese font It is also recommended to embed the Japanese font in the PDF file as long as the file size is not over the limit. Otherwise, please confirm that the file can be correctly displayed and printed with various software when the font is not embedded. If you use the Windows environment, please check that it also works with other environments such as Mac and UNIX, etc.

Please refer to the manual of your PDF conversion software about font embedding.
